Legal Medicine Perspectives. Congratulations and thanks to Dr. Liz Valencia and Dr. June Zhao for their outstanding work. They have succeeded in publishing the first two issues of Legal Medicine Perspectives (LMP) following a long lapse in publication. For those who are newer to the College, LMP has been part of a long tradition of the College; it provides a forum for sharing insights and information about cutting edge developments in legal medicine, ranging from analyses and commentaries on interesting cases to perspective pieces on important public health issues.

Journal of Legal Medicine. The College's three-year contract with Georgia State University (GSU) to oversee the editing and publication of the Journal of Legal Medicine (JLM) expired on June 30, 2021. We are actively engaged in talks with Dean Camille Davidson at Southern Illinois University (SIU), which, prior to GSU, had been a long-time academic partner of ACLM with respect to JLM. Dean Davidson has been trying to expand the health law program at SIU and is excited about the prospect of bringing JLM back to SIU. The challenge at the moment – which would be true at any law school -- is finding the right faculty member to take the helm. We have also reached out to other law schools about a potential partnership and although a number of schools have expressed interest, thus far none has been able to commit.

Accordingly, the College is putting together a Search Committee for the purpose of identifying and evaluating other prospective academic institutions that would be good partners for ACLM in publishing JLM. Bylaws Committee. Dr. Frank Woodside, who is currently Secretary for the College, is also serving as Chair of the Bylaws Committee. In that capacity, Dr. Woodside is undertaking the important task of carefully reviewing the College's Bylaws for the purpose of recommending revisions that will ultimately be voted on

by the Fellows at the next Annual Meeting of the Fellows. Dr. Woodside needs additional Bylaws Committee members who can assist with this challenging task. AMA Annual Meeting Report. Thank you to Dr. Dick Wilbur, Past President of the College, and currently one of the College's delegates to the AMA, for providing the following report:

AMA Delegate Report to ACLM

The AMA had its Annual Meeting virtually so that portions of it were held from June 5 to 16, 2021. The House of Delegates (HOD) met from the 11th to the 16th. Despite the increased amount of time, the constraints of using equipment in ways unfamiliar to many participants resulted in prolonged delays and a truncated agenda. A screening committee surveyed all Resolutions submitted and rejected or postponed a substantial number to the in person Interim Meeting scheduled for November.

Among those debated were one to lower Medicare age to 60. It lost, Medicare is already running out of money. One more directly affecting medical law was that new <u>information-blocking regulations</u> stemming from the 21st Century Cures Act require physicians to release health information even when they believe that doing so could emotionally or psychologically harm the patient. There are exceptions for information that doctors think might lead to a patient's physical harm, but not for other kinds of harm. So the HOD voted to advocate to the Office for Civil Rights to revise the definition of harm to include mental and emotional distress.

This spring, a large insurance company offered patients \$500 if they would switch from the medication their physicians prescribed to a payer-preferred alternative. Feeling that these types of insurance company tactics are likely to proliferate, the HOD adopted new policy to "oppose the practice of insurance companies providing payments to patients as financial incentives to switch treatments from those recommended by their physicians."

Health plans employ <u>prior authorization</u> and other forms of utilization management to cut health care spending. Peer-to-peer discussions between physicians and insurance company doctors are too often just another barrier to care and, therefore, the HOD advocated that proprietary criteria not supersede the professional judgment of the patient's physician when determining Medicare and Medicare Advantage patient eligibility for procedures and admissions.

The use of telehealth exploded during the COVID-19 pandemic, but critical issues related to access inequity, state medical licensure requirements, regulation and payment must now be addressed for it to continue to flourish beyond the current emergency.
